

# **GOODFELLOW PRONATURE** Treated Wood

# THE GOODFELLOW PRONATURE® TREATED WOOD LIFETIME RESIDENTIAL LIMITED WARRANTY ("LIMITED WARRANTY")

### WHAT IS COVERED

This Limited Warranty is for wood product pressure treated with copper azole sold or labeled as Goodfellow ProNature brand wood product or as covered by this Limited Warranty ("Goodfellow ProNature brand wood product"). Goodfellow Inc. will provide original consumer purchasers or "first-owners" of Goodfellow ProNature brand wood product that "structurally fails" either, in Goodfellow Inc.'s sole discretion, replacement Goodfellow ProNature brand wood product for the Goodfellow ProNature brand wood product that "structurally fails" or a refund of the monetary equivalent of the Goodfellow ProNature brand wood product that "structurally fails" up to the original purchase price.

This Limited Warranty is not transferable from an original consumer purchaser or "first-owner" to any subsequent consumer or owner, tenant, or successor of the real property on which Goodfellow ProNature brand wood product is installed.

"First-owners" means:

- the owner-of-record of the real property on which Goodfellow ProNature brand wood product was installed at the time the Goodfellow ProNature brand wood product was installed; or,
- if Goodfellow ProNature brand wood product was installed by a builder-contractor-owner in connection with new construction on real property owned by such builder-contractor-owner, the first owner-of-record that acquires such real property from the builder-contractor-owner.

"Structurally fails" means the inability of Goodfellow ProNature brand wood product to perform its intended function due to fungal decay or termite attack. "Fungal decay" means attack by wood destroying fungi that disintegrate the wood cell walls, but excludes surface mold, mildew, and/or fungi associated with the appearance or "weathering" of wood. "Weathering" of wood is not fungal decay of any type.

## TO IDENTIFY A GOODFELLOW PRONATURE BRAND WOOD PRODUCT, LOOK FOR THE END TAG

It's easy to identify Goodfellow ProNature brand wood product. Simply look for the Goodfellow ProNature Copper Azole END TAG on each piece of Goodfellow ProNature brand wood product. Make sure you receive and retain original end tag(s) for each piece of Goodfellow ProNature brand wood product, as well as the original purchase receipt(s) from your lumber dealer or contractor/ builder. In the event of a claim, it will be necessary to present this documentation for all Goodfellow ProNature brand wood protuct failed.

#### WARRANTY CONDITIONS

This Limited Warranty applies only if each of the following conditions are met

- Goodfellow ProNature brand wood product must be used only in residential applications and as specified on the end tag attached to the Goodfellow ProNature brand wood product.
- Specifically, "Above Ground" Goodfellow ProNature brand wood product must be used only in "Above Ground" applications. ("Above Ground" applications are above ground uses of Goodfellow ProNature brand wood product where the Goodfellow ProNature brand wood product is NOT in contact with soil, placed on or over soil using a synthetic barrier or plastic material, subject to frequent wetting or continually exposed to heavy vegetation, mulch products, fill dirt, or other conditions that could simulate a ground contact exposure.)

"Ground Contact" Goodfellow ProNature brand wood product can be used in either "Above Ground" or "Ground Contact" applications. "Ground Contact" applications are uses where Goodfellow ProNature brand wood product is used:

- in contact with the ground, fresh water, or other situations favourable to deterioration;
- above ground but may end up in ground contact or is subject to hazards comparable to ground contact due to climate, artificial or natural processes or construction.

Examples of "Ground Contact" use applications include fence posts, deck posts, railing posts, and timbers.

- Goodfellow ProNature brand wood products must be treated with copper azole by a licensed Goodfellow treating facility.
- Goodfellow ProNature brand wood product must be used in accordance with municipal, provincial and federal building codes.
- For the warranty to be valid for pressure treated timbers and for pressure treated wood used in ground contact applications, a brush-on copper naphthenate end-cut wood preservative is required at the time of construction on all saw cuts, drill holes and other field cuts. Two applications of a copper naphthenate end-cut wood preservative must be applied to cuts in the treated wood before it is installed.
- For the warranty to be valid for pressure treated wood used in above ground applications, such as deck boards, railing, post tops or fence boards, a brush-on end-cut wood preservative must be applied to all saw cuts, drill holes and other field cuts at the time of construction.
- Proof of purchase is required that the copper naphthenate end-cut wood preservative (ground contact) and end-cut wood preservative (above ground) was purchased before the completion of the project.

#### WARRANTY EXCLUSIONS

This Limited Warranty does not cover:

- Commercial or industrial structures, wood foundation systems, wood exposed to salt or brackish water, building poles or building timbers in structural applications, commercial vineyard stakes, peeler core landscape timbers (mini ties), shakes and shingles, specialty items, such as spindles, balusters, post caps, lattice and railing or any products that have been milled after treatment.
- The structural failure of projects or structures containing any Goodfellow ProNature brand wood product where some or all of the Goodfellow ProNature brand wood product has been used in contact with untreated or treated material that has been used in an improper application, or in contact with any older construction with any evidence of decay.
- The structural failure of "Above Ground" Goodfellow ProNature brand wood product used in contact with the ground, fresh water, or other situations favourable to deterioration or used above ground but may end up in ground contact or is subject to hazards comparable to ground contact due to climate, artificial or natural processes or construction.
- The structural failure of Goodfellow ProNature brand wood product where the Goodfellow ProNature brand wood product has been sawn lengthwise (ripped) or surfaced (sanded/planed/ etc.).
- The structural failure of Goodfellow ProNature brand wood product caused by the "weathering" of wood, including but not limited to raised grain, splitting, checking, cupping, twisting, warping, shrinkage, swelling, or any other physical or aesthetic property of the wood.
- The corrosion of fasteners, hardware, or any other material(s), including metal materials used, in conjunction with, or to wrap or encapsulate Goodfellow ProNature brand wood product, or structural failure resulting from such an occurrence.
- The delamination of Goodfellow ProNature brand wood product including plywood and other laminated wood products.
- Mold, mildew, or fungal growth on Goodfellow ProNature brand wood product that is aesthetic.
- Damage to Goodfellow ProNature brand wood product other than structural failure.

#### HOW TO MAKE CLAIMS

To make a claim under this Limited Warranty, within thirty (30) days of discovery of a defect, send photograph(s) and a description of the structural failure along with the Goodfellow ProNature brand wood product purchase receipt(s) from your lumber dealer or contractor/builder. In addition, Goodfellow Inc. requires an itemized list of Goodfellow ProNature brand wood product that structurally fails and an end tag from each piece of such Goodfellow ProNature brand wood product. Send this information to:

Subject to the terms, conditions, limitations and exclusions of this Limited Warranty, Goodfellow Inc. will, within sixty (60) days from the date of receipt of notice of your claim, and upon receipt of the proper documentation, make available to you replacement Goodfellow ProNature brand wood product in exchange for Goodfellow ProNature brand wood product that structurally failed or, in Goodfellow Inc.'s sole discretion, refund the monetary equivalent of such Goodfellow ProNature brand wood product, up to the original purchase price. Goodfellow Inc. reserves the right to have a representative inspect all Goodfellow ProNature brand wood product the inspection is denied or should the inspection reveal that in service conditions were modified or changed prior to inspection, or that the requirements of this Limited Warranty are not met, Goodfellow Inc. shall have no obligation under this Limited Warranty.

#### LIMITATIONS OF REMEDIES AVAILABLE

By purchase, acceptance, receipt, or use of Goodfellow ProNature brand wood product, the original consumer purchaser or first-owner of Goodfellow ProNature brand wood product accepts the terms, conditions, limitations and exclusions contained in this Limited Warranty.

Goodfellow Inc.'s only obligation under this Limited Warranty is to, in Goodfellow Inc.'s sole discretion, provide replacement Goodfellow ProNature brand wood product (Goodfellow ProNature brand wood product only) for the Goodfellow ProNature brand wood product that structurally failed or to refund the monetary equivalent of such Goodfellow ProNature brand wood product, up to the original purchase price. This Limited Warranty is your sole and exclusive remedy and is in lieu of all other warranties, representations, guarantees or conditions, whether expressed or implied. Goodfellow Inc. is not responsible for any costs associated with removal or disposal of any Goodfellow ProNature brand wood product or delivery or installation of the replacement Goodfellow ProNature brand wood product.

TO THE EXTENT PERMITTED BY APPLICABLE LAW, GOODFELLOW INC. MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE. IN NO EVENT SHALL GOODFELLOW INC. BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL, PUNITIVE, SPECIAL, OR INDIRECT DAMAGES, EVEN IF GOODFELLOW INC. KNEW OF THE LIKELIHOOD OF SUCH DAMAGES. Some provinces, states or other jurisdictions do not allow limitations on the length of implied warranties or conditions, or do not allow the exclusion or limitation of certain types of damages, or the exclusion or limitation of liability for death or personal injury caused by that party's negligence. If that is true of the first-owner's province, state or jurisdiction, the above limitations or exclusions shall not apply except to the maximum extent permitted by such applicable law. You have specific rights under this Limited Warranty. However, you may also have other rights which vary from jurisdiction to jurisdiction and nothing in this Limited Warranty will apply to reduce or eliminate any of your mandatory, statutory rights.

The parties agree that they will resolve their disputes on an individual basis, and that any claims brought under this Limited Warranty or in connection with the Goodfellow ProNature brand wood product must be brought in the parties' individual capacity.

Goodfellow Inc.'s failure at any time to enforce any of the terms, conditions, limitations or exclusions stated in this Limited Warranty shall not be construed to be a waiver of such provisions. This Limited Warranty constitutes the complete and exclusive agreement between you and Goodfellow Inc. with respect to the subject matter contained in this Limited Warranty and supersedes any and all prior oral or written agreements or representations. Any and all representations, promises, warranties or statements by Goodfellow Inc. or its agents that differ in any manner from the terms of this Limited Warranty are of no force or effect unless in writing, signed by a duly authorized officer of Goodfellow Inc.

Invalidity or unenforceability of any provision of this Limited Warranty shall not affect the validity or enforceability of any other provision, all of which shall remain in full force and effect.

This Limited Warranty is valid only for Goodfellow ProNature brand wood product produced and used in Canada in 2024-2025.
